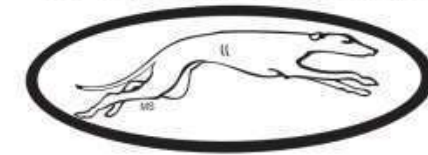

## NEW Parking/Admission Fees:

**PARKING & FEES** – Due to changes in Kentucky Horse Park policy, the Bluegrass Classic Dog Shows are no longer allowed to prepay parking for our exhibitors and spectators. All vehicles will need to pay the **Kentucky Horse Park parking fee of \$5.00 per day or purchase a \$15 Five-Day Event Pass** at the front gate. Please note that parking fee money is retained fully by the Kentucky Horse Park. **PLEASE PLAN TO ARRIVE EARLY** to avoid traffic at the gate as other events are being held at the Kentucky Horse Park during the Bluegrass Classic.

**ALLTECH ARENA ADMISSION** – There is a \$5 per carload per day admission charge, or a \$25 Five-Day Event Admission Pass with in/out privileges is available, to **ALL** dog events (Conformation, Obedience and Rally, CGC, Trick Dog, Lure Coursing, and Dock Diving) upon arrival at the Alltech Arena. Five-Day Event Admission Passes may be purchased on Wednesday in the Alltech Arena from 2:00 P.M. to 8:00 P.M. or are available at the Alltech gate during the shows. The admission fee helps to pay for the rising cost of our venue.

## **KHP Campground Info**

**PARKING & FEES** - All attendees/exhibitors for any of the Bluegrass Classic dog events will have free entry into the KY Horse Park. Please tell the attendant at the Main Gate that you are there for the Bluegrass Classic Dog Show to receive free entry into the Horse Park.

There is an admission charge to the Alltech Arena, and any of dog events (Conformation, Barn Hunt, Lure Coursing and Dock Diving, Rally and Obedience) which is \$7.00 per car load, per day or \$30.00 for a 5-day Event Pass that includes in/out privileges.

**RECREATIONAL VEHICLE PARKING** - All RV camping/parking at the Kentucky Horse Park must be arranged through the Campground store. Please call (859) 259-4257 for reservations, press 2 at the prompt and you will be taken to reservations. **YOU MUST STATE YOU ARE WITH THE BLUEGRASS CLASSIC DOG SHOWS. THIS WILL PUT YOU INTO THE RESERVED BLOCK FOR THE SHOW PARTICIPANTS. WE HAVE 80 SPACES RESERVED FOR OUR SHOW. CAMPGROUND SPACES REQUIRE A 5 NIGHT RESERVATION WHICH IS \$40.00.**

**IF YOU ARE WANTING TO PARK AN RV IN THE PARKING LOT AT THE ARENA YOU MUST HAVE A PRIMITIVE PERMIT WHICH IS PURCHASED AT THE CAMPGROUND STORE.** It is located on the Kentucky Horse Park property about one mile from Alltech Arena. You may use your motor vehicle through the main gate or golf cart on the property grounds to get to the Alltech Arena, and other dog events. (There is an admission fee so make sure you have your pass) There are a limited number of primitive RV parking sites available around the Alltech Arena. You must be self-contained to use these spots. **ALL RVS MUST GO TO THE CAMPGROUND FIRST TO CHECK IN FOR THE PRIMITIVE RV PARKING BY THE ALLTECH ARENA, IF YOU DO NOT YOU WILL BE TICKETED, TOWED AND OR FINED.**

The field has a little shade. 3 and 4 board horse fencing with plastic mesh temporary fencing. Rough mowed grass with slightly hilly terrain.

**Please bring your own shade and water.**

Battery powered, continuous loop lure machines will be used. The lure will consist of plastic strips.

Only the Lure Operator, Huntmaster, Judges and Handlers of the hounds running on the course in progress will be permitted near the lure machine. The members of the Greyhound Association of North Georgia reserve the right to alter the course plan as required by weather and/or field conditions on the day of the trial.

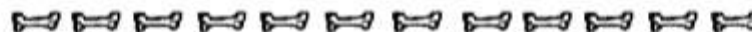

Pick up after your dog indoors and out. All dogs must be crated while in your room with plastic under the crate. An Event Committee Hearing will be held for individuals reported for any hotel complaint which includes failure to clean up poop.



### CONCERNED.

- All exhibitors read the regulations on hotel/motel accommodations.
- All motels accepting dogs require plastic under crates  
Plastic sheeting is to be placed under every crate in motel rooms. This will keep carpets clean & dry. It will be the responsibility of each exhibitor to provide his/her own plastic sheeting for each crate.
- Dogs must be crated when owner is out of the room. NO EXCEPTIONS!
- Dogs must be kept on a leash at all times while in the hotel, lobbies or on hotel grounds. Rooms & lobby must be kept clean of dog debris.
- Dogs should be “exercised” in designated areas on motel premises. Every dog owner/handler is expected to pick up after his/her dog & dispose of waste in designated trash cans. It is the responsibility of the dog owner to find out from the innkeeper where these areas & cans are located.
- Due to severe clogging problems with the drain pipes, no dog may be bathed in the hotel. Crating & bathing facilities with hot & cold water are available at the show site.
- Rooms will be inspected daily by members of the hotel staff & observed violations or damages will be reported to the hotel management and/or the investigative committee.
- The investigative committee, working with a fair & equitable system, is charged with investigating complaints.
- Each dog owner/registrant is expected to cooperate with the investigative committee, hopefully settling damage claims on the spot,



or else must be willing to furnish information such as insurance policy numbers & other pertinent information as required/requested.

- Should a hotel/motel, for cause, deem it necessary to cancel room privileges, the registrant agrees to forego legal actions against CLUSTER CLUBS & the hotel/motel.
- As an exhibitor, be aware that violations may be referred to the Event Committee if written charges are preferred. If such charges are upheld by the Event Committee, it may lead to suspension from future show privileges.

##### ALL DOGS RUN AT OWNERS SOLE RISK

##### NOTICE TO ALL EXHIBITORS

All entries must be one year of age or older on the day of the test.

- Each dog requires an individual entry form for each event in which it is entered. Or enter online (EASIER!!)
- Entries will not be accepted without fees, signatures, or the "Agreement" found on the Official AKC Entry Form.
- Bitches in season and lame dogs will be refused entry and, if presented at inspection, will be refunded entry fees.
- Mixed breeds must be spayed or neutered to be eligible to run. AKC registered dogs with breed disqualifications may be entered.
- Coursing is an athletic activity that can tax a dog's physical strength.
- Dogs that are overweight and/or out of condition may be at greater risk for injury and exhaustion. The Inspection Committee has the authority to disallow a dog's entry into a test, and in such instances, applicable entry fees will be refunded.
- Battery powered, continuous loop lure machines will be used. The lure will consist of white plastic strips. Backup equipment will be available.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of parasites, any communicable diseases and have appropriate vaccinations.
- The Huntmaster is responsible for field safety and therefore he/she is in complete charge of all dogs and handlers on the field. In service to this responsibility, he/she has the authority to stop the lure in any potentially dangerous situation and signal the handler to retrieve a testing dog.
- Any decisions made by the event's officiating judge(s) regarding the performance of an entered dog shall be final. Full discretionary power is given to the judge(s) to withhold any and all qualifications for lack of merit. The Judge(s) is responsible for ensuring compliance with the AKC Regulations on the field.
- No entry fees will be refunded if the event cannot be started or

completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or its members and representatives.

- Persons exhibiting conduct detrimental to AKC/GANG/any dog(s)/other person(s) will be asked to leave the trial site.
- The event-hosting club, its agents, members, representatives, volunteers, etc., assume no liability or responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs

or property and further assumes no responsibility for injury to children or spectators before, during, or after this event

- There will be restroom facilities located near the field. Bring your own shade. No littering. Pick up after your dogs. There will be a \$5.00 fine for NOT cleaning up after your hounds. There will be a \$5.00 fine for any dogs off lead on the trial grounds ~ including after the trial. A \$5.00 fee for any cigarette butts on the ground.
- All rights to televise, videotape, advertise, photograph, promote or otherwise exploit this event are vested in the club, or in persons to whom assignments of such rights have been made in writing by the club. All persons and animals attending these shows grant the club the right to use their likeness and voice in any matter without further consent.
- A penalty of \$5.00 will be assessed for any and each loose dog(s) not competing in the course in progress.
- A return check fee of \$35.00 will be assessed for any check(s) returned for insufficient funds.
- A penalty of \$5.00 /minute over the allotted run time (2 minutes for 600 yard dogs and 1.5 minutes for 300 yard dogs) will be assessed for any handler/dog that is not leashed and under control (at the discretion of the judge).

**ML Baer Photography is the official photographer for these events. No other photographer will be allowed to photograph dogs/people without the express consent of ML Baer Photography and the Trial Chairman. Anyone caught photographing these events, or any portion thereof, without permission will be asked to leave the field. An AKC Event Committee hearing may also be called if unsportsmanlike behavior is evident.**
