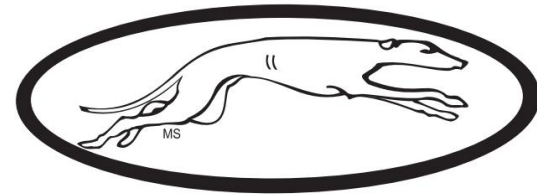

Eligible breeds and registry (Regular LC Trial and JC/QC Only!)

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Portuguese Podengos, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Thai Ridgebacks and Whippets that are one year of age or older, that have been registered with the AKC, or part of an AKC-registered litter, or otherwise, if whelped outside the USA and owned by a resident of the USA, or of a country with a foreign registry organization whose pedigrees are acceptable for AKC registration and is registered with that registry, or that have been granted an ILP, are eligible to participate. Hounds may not be entered as "registration pending" or "ILP pending". Breed disqualifications apply.

COURSE PLANS

The courses will be reversed for the finals, run-offs, and Best of Breed, or at the discretion of the judges. The club reserves the right to alter the course plan as required by weather and/or field conditions on the day of the trial. The field is completely fenced.

Terrain is mowed field, gently rolling, sloped.

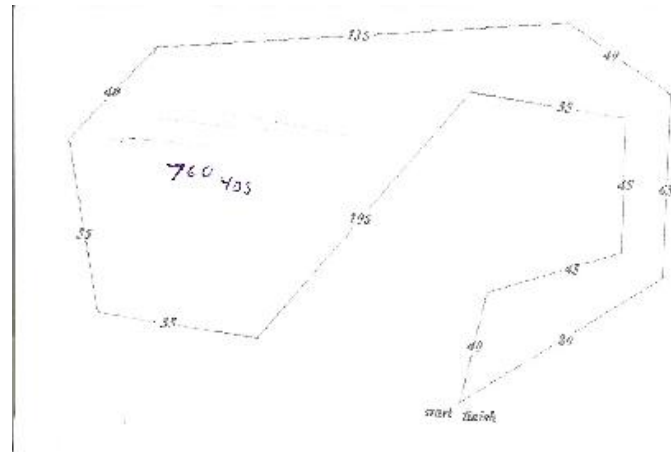
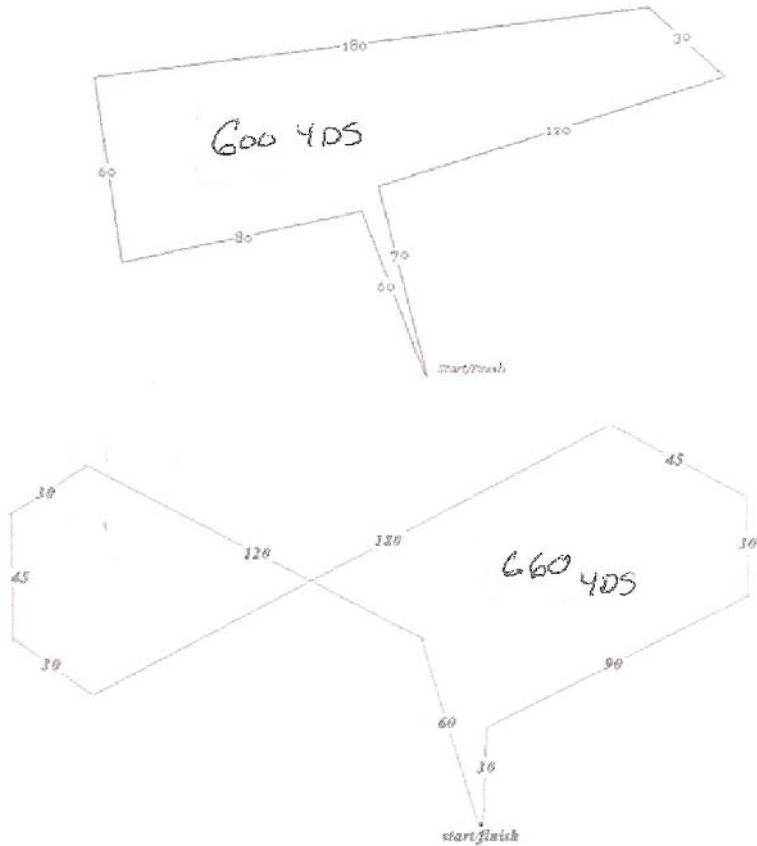
