

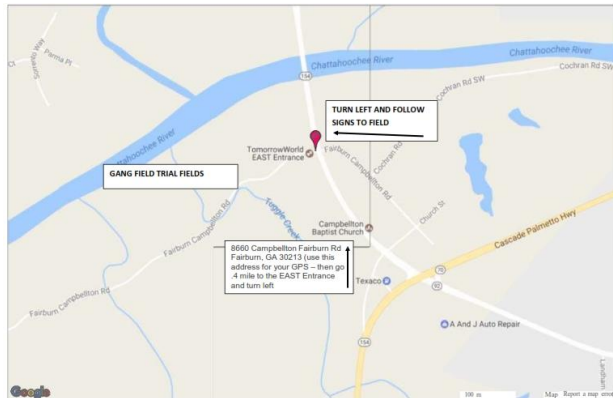

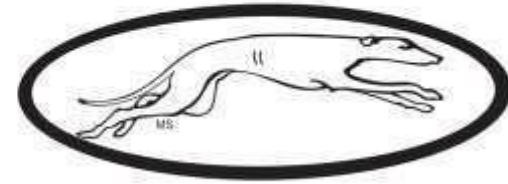

Ribbons or rosettes will offered for all placements.**First=Blue, Second=Red, Third=Yellow, Fourth=White, NBQ=Green,****Highest Scoring Single=Navy/Gold, Best of Breed=Purple/Gold,****& Best in Field=Red, White & Blue.****ELIGIBLE BREEDS & REGISTRY**

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis and Whippets breeds may be entered in the regular stakes.

Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

REGULAR STAKES OFFERED**OPEN STAKE:** Any eligible sighthound, excluding ASFA Field Champions of record.**FIELD CHAMPION STAKE:** Any ASFA Field Champion**VETERAN STAKE:** Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.**LIMITED STAKE:** Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.**SINGLE STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.**BEST IN FIELD WILL BE OFFERED**

Conditions of Entry: All entries must be one year or older on the day of the trial • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more • Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. • Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake • Hounds not present at the time of roll call will be scratched • All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

Equipment: Type of lure machine: battery-powered continuous-loop system. • Type of lures: highly-visible white plastic strips and/or fur • Back-up equipment will be available.

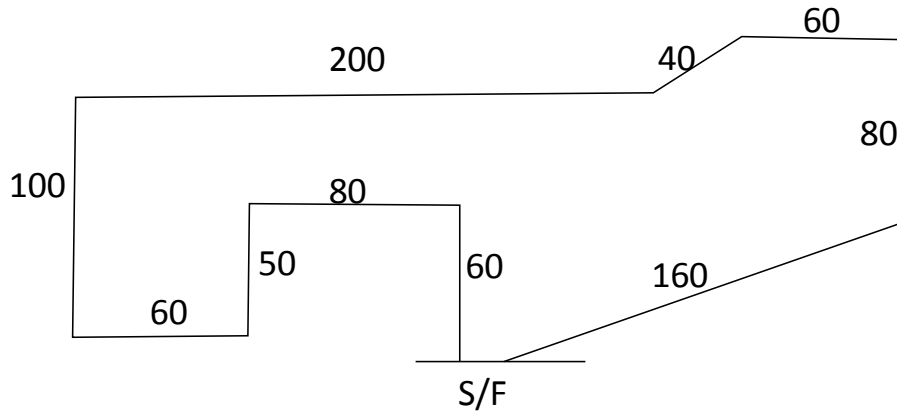

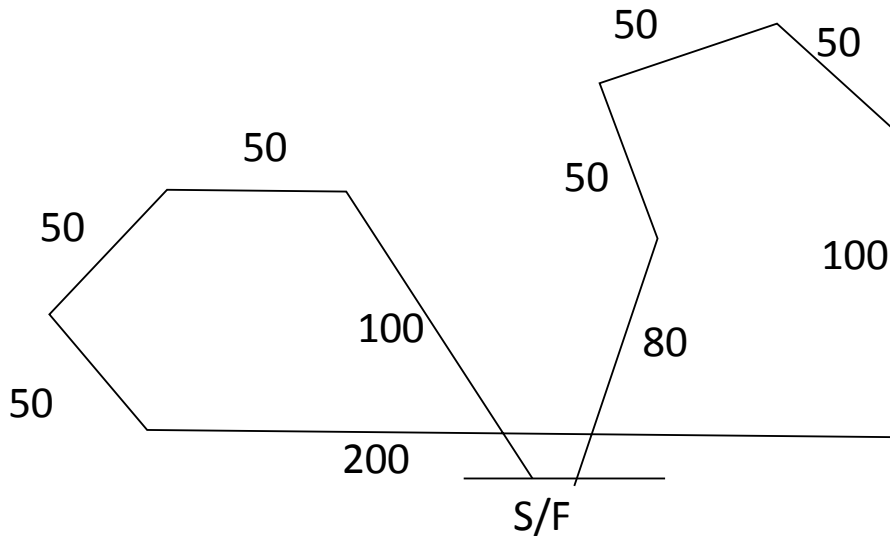
COURSE PLANS

Facility Information

Chattahoochee Hills Eventing is located on Olympic Three Day Event rider Carl Bouckaert's farm in Chattahoochee Hill country.

This 8,000 acre equestrian paradise is filled with well-established rolling pastures, lakes, and woodlands that run 12 miles along the Chattahoochee River.

The farm is only 15 miles west of Atlanta's Hartsfield Airport and a short drive to the convenience of South Fulton Parkway.

Care of the Grounds

Kindly enter the field at the designated area only. Parking areas will be clearly marked. Please clean up after your hounds. Smokers please do not leave cigarette butts on the ground. There will be a \$15 fine levied on all smokers leaving cigarette butts on the grounds or people caught not cleaning up after their dogs!!

PLEASE NOTE:

Horses and Riders have the Right of Way!! Drive SLOWLY. Follow signs.

Please bring your own shade and water.

There will be portable toilets available – DO NOT put poop bags in the toilet!!!

- NO CONCESSIONS AT THE FIELD.

- All owners must keep their hound under control at all times. There will be a \$5 fine assessed for any loose hound on the field not taking part in the course in progress.
- There will be a \$15 fine assessed for any owner who does not clean up after his/her hound. Deposit poop bags in trash only, not in or near a port o pot or against trees.
