## <u>Awards</u>

Qualifying ribbons will be awarded to all qualifiers in all classes and placement ribbons will be awarded for 1<sup>st</sup> – 4<sup>th</sup> place in all classes and height group *excluding* Instinct. New title ribbons and High in Class ribbons will also be awarded. A Beautiful RATCH Ribbon will be awarded to all who achieve this high honor!

"Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations."

All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. There will be a \$35 fee for all returned checks. No entries will be taken over the phone or electronically. Exhibitors are responsible for complete, accurate, and legible information on the entry forms. Illegible or incomplete entries cannot be entered into the show.

Owners or handlers entering dogs in a trial do so at their own risk and agree to assume responsibility for damage caused by them, or by their dogs and hold the trial club and Barn Hunt Association harmless for any injury sustained by their dog or by a person during the trial. By entering a trial, owners attest that they have read, understand, and will abide by all Barn Hunt rules.

It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made. No entry fees will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, Act of God, public emergency, act of a public enemy, strike, or any other cause beyond the control of the organizers.

Bitches in Season (BIS) may participate in the trial, subject to compliance with BHA requirements. Owners of BIS should make their condition known to the Trial Secretary prior to arrival if at all possible, notify a committee member upon arrival at the trial, and inform the judge during the briefing. BIS must wear appropriate pants/britches at all times when not being pottied, including on the course. Owners of BIS should crate/confine their dogs away from traffic and other dogs, should post "dog in season" signs on their crate/in their area, and potty the dog away from other competitors. At the discretion of the host, a separate area may be designated for BIS for pottying purposes. Failure to notify the club and fellow competitors of a BIS results in a disqualification and dismissal from show grounds.

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform required elements safely. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from the competition by action of the show committee.

All dogs must be on a leash and under control while on trial grounds. Approved collars include flat snap or buckle collars of solid construction and leather or nylon leads. Limited slip martingale collars are allowed. Single piece slip collars/leads are allowed. Harnesses, with the exception of head-halter types, are allowed. Dogs MUST run "naked," without a collar/harness. Collars/harnesses which can be easily and quickly removed and replaced are strongly encouraged. NO flexi-leads allowed in trial area.
