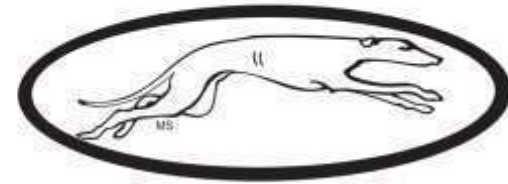
**DIRECTIONS:** We will be using the Steeplechase field. The field is just off of Centennial Olympic Parkway and across the street from the Hawthorn Suites.. The field is in Rockdale County, GA, approx. 24 miles east of Atlanta. For more information, go to <http://georgiahorsepark.com> From Atlanta and the west: Take I-20 east. Exit I-20 at Exit 82 (GA-20 N/GA-138 E) toward Monroe/Conyers. Travel north on GA-20/GA-138 approx. 4 mi. Turn right onto Centennial Olympic Parkway. The entrance to the field is 2 mi ahead on the right. Follow signs. From the east: Take I-20 west. Exit I-20 at Exit 84 (GA-162/Salem Rd). Exit right onto GA-162/Salem Road (which becomes Sigman Road) for approx.. 1.1 mi. Turn right onto Gees Mill Road for approx.. 2.5 mi. Pass Gate A. Turn right onto Centennial Olympic Parkway. Pass Gate B and the traffic light. Turn right into the main entrance to the park on the right. Follow signs to the field

**ELIGIBLE BREEDS & REGISTRY**

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell’Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis and Whippets breeds may be entered in the regular stakes.

Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound’s first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

**REGULAR STAKES OFFERED**

**OPEN STAKE:** Any eligible sighthound, excluding ASFA Field Champions of record.  
**FIELD CHAMPION STAKE:** Any ASFA Field Champion  
**VETERAN STAKE:** Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.  
**LIMITED STAKE:** Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.  
**SINGLE STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

**BEST IN FIELD WILL BE OFFERED**

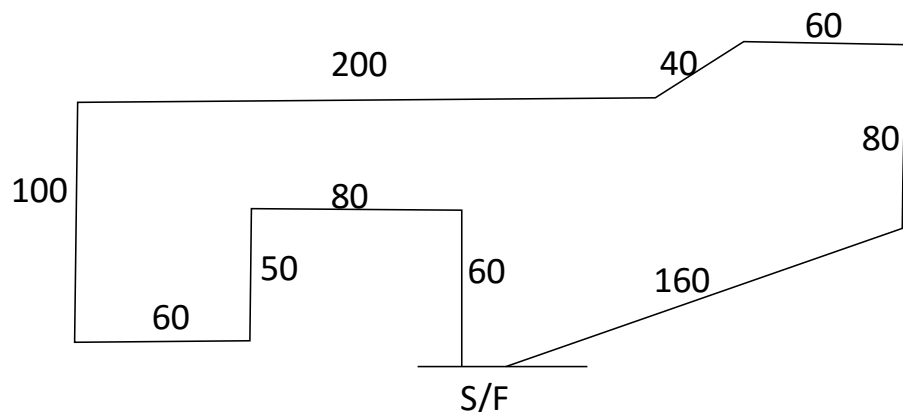
**Conditions of Entry:** All entries must be one year or older on the day of the trial • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more • Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. • Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake • Hounds not present at the time of roll call will be scratched • All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

**Equipment:** Type of lure machine: battery-powered continuous-loop system. • Type of lures: highly-visible white plastic strips and/or fur • Back-up equipment will be available.

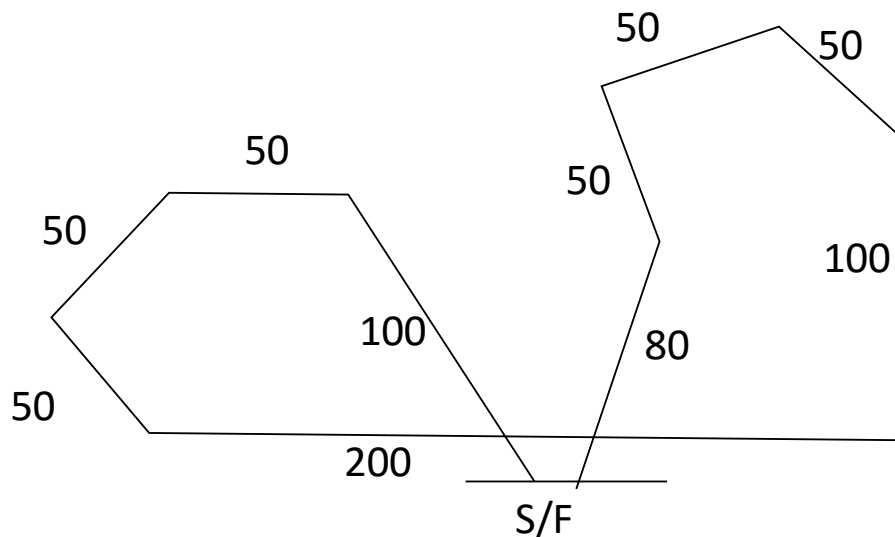
## COURSE PLANS

These course plans comply with ASFA Rule Section 8, Item 3 (s), page 14. GANG reserves the right to alter the course due to field and/or weather conditions on the day of the trial. Course will be reversed for finals, runoff and BOB. Terrain is gently rolling. The field is not fenced, some snow fence will be added. Each hound is entered and competes at the sole risk of its owner. It is recommended that hounds are in good physical condition.
